

## 1. Gortnahoe N.S. Child Safeguarding Statement



Gortnahoe NS is a primary education to pupils from Junior Infants to Sixth Class.

In accordance with the requirements of the Children First Act 2015, Children First: National Guidance for the Protection and Welfare of Children 2017, the Addendum to Children First (2019), the Child Protection Procedures for Primary and Post-Primary Schools (revised 2023) and Tusla Guidance on the preparation of Child Safeguarding Statements, the Board of Management of Gortnahoe NS agreed the Child Safeguarding Statement set out in this document.

- 1 The Board of Management has adopted and will implement fully and without modification the Department's *Child Protection Procedures for Primary and* Post-Primary Schools (*revised 2023*) as part of this overall Child Safeguarding Statement
- 2 The Designated Liaison Person (DLP) is David O'Dwyer
- 3 The Deputy Designated Liaison Person (Deputy DLP) is Ciara Lanigan
- 4 The Relevant Person is David O'Dwyer (*The relevant person is one who can provide information in respect of how the child safeguarding statement was developed and will be able to provide the statement on request. In a school setting the relevant person shall be the designated liaison person.*)
- 5 The Board of Management recognises that child protection and welfare considerations permeate all aspects of school life and must be reflected in all of the school's policies, procedures, practices and activities. In its policies, procedures, practices and activities, the school will adhere to the following principles of best practice in child protection and welfare:

The school will:

- recognise that the protection and welfare of children is of paramount importance, regardless of all other considerations;
- fully comply with its statutory obligations under the Children First Act 2015 and other relevant legislation relating to the protection and welfare of children;
- fully co-operate with the relevant statutory authorities in relation to child protection and welfare matters;
- adopt safe practices to minimise the possibility of harm or accidents happening to children and protect workers from the necessity to take unnecessary risks that may leave themselves open to accusations of abuse or neglect;
- develop a practice of openness with parents and encourage parental involvement in the education of their children; and
- fully respect confidentiality requirements in dealing with child protection matters.

The school will also adhere to the above principles in relation to any adult pupil with a special vulnerability.

- 6 The following procedures/measures are in place:
  - In relation to any member of staff who is the subject of any investigation (howsoever described) in respect of any act, omission or circumstance in respect of a child attending the



school, the school adheres to the relevant procedures set out in Chapter 7 of the *Child Protection Procedures for Primary and Post Primary Schools (revised 2023)* and to the relevant agreed disciplinary procedures for school staff which are published on the gov.ie website.

- In relation to the selection or recruitment of staff and their suitability to work with children, the school adheres to the statutory vetting requirements of the <u>National Vetting Bureau</u> (<u>Children and Vulnerable Persons</u>) Acts 2012 to 2016 and to the wider duty of care guidance set out in relevant Garda vetting and recruitment circulars published by the Department of Education and available on the gov.ie website.
- In relation to the provision of information and, where necessary, instruction and training, to staff in respect of the identification of the occurrence of harm (as defined in the 2015 Act) the school-
  - Has provided each member of staff with a copy of the school's Child Safeguarding Statement
  - Ensures all new staff are provided with a copy of the school's Child Safeguarding Statement
  - Encourages staff to avail of relevant training
  - > Encourages Board of Management members to avail of relevant training
  - > The Board of Management maintains records of all staff and Board member training
- In relation to reporting of child protection concerns to Tusla, all school personnel are required to adhere to the procedures set out in the *Child Protection Procedures for Primary and Post Primary Schools (revised 2023)*, including in the case of registered teachers, those in relation to mandated reporting under the Children First Act 2015.
- All registered teachers employed by the school are mandated persons under the Children First Act 2015.
- In accordance with the Children First Act 2015 and the Addendum to Children First (2019), the Board has carried out an assessment of any potential for harm to a child while attending the school or participating in school activities. A written assessment setting out the areas of risk identified and the school's procedures for managing those risks is included with the Child Safeguarding Statement.
- The various procedures referred to in this Statement can be accessed via the school's website, the gov.ie website or will be made available on request by the school.

**Note:** The above is not intended as an exhaustive list. Individual Boards of Management shall also include in this section such other procedures/measures that are of relevance to the school in question.

7 This statement has been published on the school's website and has been provided to all members of school personnel, the Parents' Association (if any) and the patron. It is readily accessible to parents and guardians on request. A copy of this Statement will be made available to Tusla and the Department if requested.

# **Appendix 1**

# **Gortnahoe N.S. Child Safeguarding Risk Assessment**

**Important Note:** It should be noted that risk in the context of this risk assessment is the risk of "harm" as defined in the Children First Act 2015 and not general health and safety risk. The definition of harm is set out in Chapter 4 of the *Child Protection Procedures for Primary and Post-Primary Schools 2023* 

In undertaking this risk assessment, the board of management has endeavoured to identify as far as possible the risks of harm that are relevant to this school and to ensure that adequate procedures are in place to manage all risks identified. While it is not possible to foresee and remove all risk of harm, the school has in place the procedures listed in this risk assessment to manage and reduce risk to the greatest possible extent

The Addendum to Children First: National Guidance for the Protection and Welfare of Children published in January 2019 clarifies that organisations providing relevant services to children should consider the specific issue of online safety when carrying out their risk assessment and preparing their Child Safeguarding Statement.

The Guidance on Continuity of Schooling for primary and post-primary schools (April 2020) advises of the importance of teachers maintaining the safe and ethical use of the internet during distance learning and assisting parents and guardians to be aware of their role also. Schools should ensure that their Acceptable Use Policy (AUP) informs and guides remote or distance learning activity.

- > Students participating in work experience in the school
- Student teachers undertaking training placement in school
- Use of video/photography/other media to record school events

- Risk of harm due to inappropriate use of online remote teaching and learning communication platform such as an uninvited person accessing the lesson link, students being left unsupervised for long periods of time in breakout rooms
- Risk of harm due to bullying of child
- > Risk of harm due to inadequate supervision of children in school
- > Risk of harm due to inadequate supervision of children while attending out of school activities
- Risk of harm due to inappropriate relationship/communications between child and another child or adult
- Risk of harm due to children inappropriately accessing/using computers, social media, phones and other devices while at school
- > Risk of harm to children with SEN who have particular vulnerabilities
- > Risk of harm to child while a child is receiving intimate care
- Risk of harm due to inadequate code of behaviour
- ▶ Risk of harm in one-to-one teaching, coaching situation
- Risk of harm caused by member of school personnel communicating with pupils in an inappropriate manner via social media, texting, digital device or other manner
- Risk of harm caused by member of school personnel accessing/circulating inappropriate material via social media, texting, digital device or other manner
- Risk of social media influences



# 3. The school has the following procedures in place to address the risks of harm identified in this assessment

- School Personnel are required to adhere to the Child Protection Procedures for Primary and Post Primary Schools (revised 2023), and all registered teaching staff are required to adhere to the Children First Act 2015
- > Child Protection Oversight Report included in every Board of Management meeting.
- > The school implements in full the R.S.E. and Stay Safe Programmes
- The school implements in full the SPHE curriculum (see detailed Whole School SPHE Plan and RSE Policy)
- > The school covers Internet Safety through the SPHE curriculum and use Webwise
- The school has an Anti-Bullying Policy which fully adheres to the requirements of the Department's Anti-Bullying Procedures for Primary and Post-Primary Schools
- The school has a supervision policy to ensure appropriate supervision of children during, assembly, dismissal and breaks and in respect of specific areas such as toilets, changing rooms etc.
- The school has in place clear procedures in respect of school outings (please refer to Supervision Policy and Code of Behaviour)
- > The school has a Health and Safety policy
- The school adheres to the requirements of the Garda vetting legislation and relevant DES circulars in relation to recruitment and Garda vetting.
- The school adheres to the "Code of Professional Conduct for Teachers" as set out by the Teaching Council.
- > The school complies with the agreed disciplinary procedures for teaching staff
- > The school has a Special Educational Needs policy
- > The school has a policy for Bus Escorts
- > The school has an intimate care policy and plan in respect of students who require such care
- The school has in place procedures for the administration of medication to pupils (provided in our Health & Safety Policy)
- ➤ The school –
- Has provided each member of school staff with a copy of the school's Child Safeguarding Statement
- Ensures all new staff are provided with a copy of the school's Child Safeguarding Statement
- Encourages staff to avail of relevant training
- Encourages board of management members to avail of relevant training
- Maintains records of all staff and board member training
- The school has in place procedures for the administration of First Aid (as part of our Health & Safety Policy)
- > The school has in place a Code of Behaviour for pupils
- > The school has an Internet Acceptable Use Policy in place, to include provision for online teaching and learning remotely, and has communicated this policy to parents
- The school has in place procedures governing the use of devices in the school by pupils as per circular 38/2018
- Mobile phones are not allowed in our school. Mobile Phones are also dealt with in our Code of Behaviour and Anti-Bullying Policy (Cyberbullying section is also contained in our Anti-Bullying policy)
- > The school has in place a Critical Incident Management Plan



- The school has in place procedures for the use of external persons to supplement delivery of the curriculum.
- The school has in place procedures for the use of external sports coaches. Teacher/ SNA always remain present.
- > The school has in place clear procedures for school swimming.
- An individual member of the school staff will not carry a single child on his/her own in their car at an time (unless there is an immediate danger or risk to the child)
- Children should only travel in staff cars in exceptional circumstances and if the teachers/ staff members has completed an Indemnity Declaration Form as per circular 0017/2016
- > The school has in place clear procedures for one-to-one teaching activities and there is glass in all doors.
- The school has in place procedures in respect of student teacher placements. No phones are to be used during placement.
- The school has in place procedures in respect of students undertaking work experience in the school. No phones are to be used during placement.
- Serving mass during school time is no longer practised in Gortnahoe NS. A parent may request for their child to serve a particular mass e.g. Funeral/ Wedding. If this is the case the school must be provided with the appropriate permission from the priest and parents. In this case the child must be collected from school and returned afterwards.

In undertaking this risk assessment, the board of management has endeavoured to identify as far as possible the risks of harm that are relevant to this school and to ensure that adequate procedures are in place to manage all risks identified. While it is not possible to foresee and remove all risk of harm, the school has in place the procedures listed in this risk assessment to manage and reduce risk to the greatest possible extent.
